Policies & Regulations

See www.pikelake.com for a complete overview of the policies and expectations of all members, guests, and visitors to the Pike Lake Golf Club.

General: Members of Pike Lake are expected to respect and adhere to the Club's policies and regulations. We expect our members to uphold the highest standards of personal conduct so to reflect a positive image for other members and guests.

Check-in: All golfers are required to sign in at the Pro Shop upon arrival. All play must start on the designated first tee unless otherwise stated by the Pro Shop staff. Jumping courses or holes is prohibited during play.

Tee Time Booking Policy: Members are expected to reserve tee times in advance and are encouraged to book in foursomes especially during peak times. Openings in any twosomes or threesomes will be filled by the Pro shop staff as necessary. No-shows or duplicate bookings may result in loss of booking privileges. Bookings will be accepted 10 days in advance by telephone.

Dress Code: All Members and Guests are required to wear suitable attire on the course and in the Clubhouse facilities.

Handicaps: The Golf Canada Handicap System is available in the Pro Shop and is designed to give equitable handicaps no matter where golfers play. Members must have a valid handicap to play in any club sanctioned event. It is important for all members to have valid up-to date handicaps to ensure fairness to both opponents and partners in both Club matches and friendly games. Members should be submitting scores into the system at the end of each round. Two nine hole scores may be used if playing within three weeks of each other. RCGA Rules provide for penalties in situations of abuse. Members who belong to two or more clubs should record the scores of every round, regardless of the course, into each handicap system where they belong to establish and maintain a proper handicap.

Charge Accounts: Charge accounts are available to all members. Please see Pro Shop or Main Office administration to arrange a monthly charge account. Payment for invoices will be processed by credit card on the 28th of each month. Outstanding accounts will be charged interest at a monthly rate of 2%. Statements will soon be available for viewing online from our website.

Pike Lake Alcohol Policy: In accordance with the Ontario Liquor Laws, **NO** alcoholic beverages, other than those sold by Pike Lake in our licensed premises or from its cart on the golf course shall be brought to or consumed on the premises. Pike Lake Management & Staff want our guests to have a very safe and pleasant stay every time you visit our facilities. Members and guests are encouraged to use and enjoy our facilities but, Pike Lake requires everyone to comply with all of its policies and procedures, and the laws of the Province of Ontario, including all rules and regulations of the Alcohol and Gaming Commission with respect to the service and consumption of alcoholic beverages.
