**General:** Members of Pike Lake are expected to respect and adhere to the Club's policies and regulations. We expect our members to uphold the highest standards of personal conduct so to reflect a positive image for other members and guests.

**Range Usage:** Range memberships are for your personal use only. Any non-sanctioned use of your range pass may result in the immediate loss in services.

**Tee Time Booking Policy:** Members are expected to reserve tee times in advance and are encouraged to book in foursomes especially during peak times. Openings in any twosomes or threesomes will be filled by the Pro shop staff as necessary. No-shows or duplicate bookings may result in loss of booking privileges. Bookings will be accepted 10 days in advance by telephone.

**Dress Code:** All Members and Guests are required to wear suitable attire on the course and in the Clubhouse facilities.

**Charge Accounts:** Charge accounts are available to all members. Please see Pro Shop to arrange a monthly charge account. Payment for invoices will be processed by credit card on the 28<sup>th</sup> of each month. Outstanding accounts will be charged interest at a monthly rate of 2%. Statements will soon be available for viewing online from our website.

**Pike Lake Alcohol Policy:** In accordance with the Ontario Liquor Laws, **NO** alcoholic beverages, other than those sold by Pike Lake in our licensed premises or from its cart on the golf course shall be brought to or consumed on the premises. Pike Lake Management & Staff want our guests to have a very safe and pleasant stay every time you visit our facilities. Members and guests are encouraged to use and enjoy our facilities but, Pike Lake requires everyone to comply with all of its policies and procedures, and the laws of the Province of Ontario, including all rules and regulations of the Alcohol and Gaming Commission with respect to the service and consumption of alcoholic beverages.
